Aphids on trees

Since I've been back in the office I've had quite a few horticulture calls but this one started with an unusual description. "My Elm tree is raining sap" was the description that they gave which turned out to be pretty accurate once I visited the house and took a look at the tree. This beautiful American Elm was indeed "raining" something but fortunately for the tree it wasn't sap but rather Honeydew from Aphids which had infested the tree.

Aphids are a fairly common pest of trees in North Dakota and I have encountered them on numerous trees in the county over the past few years. They overwinter in bark and twigs as eggs and then hatch in the spring. Aphids are unique in that they can reproduce without mating and unfortunately under the right conditions their numbers can escalate rapidly. Aphids feed on the leaf juices of plants causing stippling and deformed leaves.

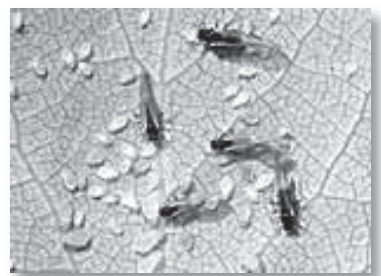
Aphids are known to have one of the least efficient digestive systems of insects (only digesting 3 percent of what they take in) and the extra is excreted as "honeydew" from the insect. Another common sign that you have aphids is an increase of ants in the area. Ants will care for and protect aphids in order to get the honeydew they secrete which I saw on a Burr Oak tree I looked at this past week as well. Often this honeydew is then infested with a sooty black mold giving the tree a dark appearance.

Typically aphids won't damage a tree but there are several control options available if you want to stop the honeydew from raining down on your patio:

- Water is often the best treatment. Once knocked off the tree Aphids typically can't return to it or are drowned. A strong stream of water or a heavy rainstorm can drastically reduce the population without further work.

- As a population of aphids increases the number of predators on them also increases. Ladybugs and lacewings all eat aphids and populations of those insects will increase to help keep the population in check. You can also order or purchase beneficial insects to help jump start the process.

- If the above two options aren't working you can apply chemicals. Look for systemic insecticides using 'acephate' as the active ingredient. You could also use a soil drench with 'imidacloprid' but those treatments take longer to reach all portions of the tree so

applications of those products should be limited to early spring before the aphid control gets out of hand. The concern with chemicals is they will kill the bad pest but they will also kill the beneficial insects as well so as the Aphids begin to repopulate, predators will take longer to recover and control the issue.

Hopefully your summer isn't interrupted by "raining sap" but if it does, look on the undersides of the leaves for aphids or give our office a call at 462-8541 and we would be happy to check out the issue for you.

Five ways to prepare zucchini

What do you call zucchini that is made into a noodle? A zoodle!

Zucchini is a type of summer squash that has a mild flavor and can be used in a variety of ways. Whether you make it sweet, spicy or savory, it provide a nourishing amount of vitamin A, vitamin C and potassium.

Select zucchini that is about 6 to 8 inches long and is firm to the touch. The squash will feel heavy and have a dried-out stem. Zucchini can be green or yellow with a glossy texture.

Be sure to rinse the zucchini under cold, running water just before you plan to use it in a recipe. You can eat zucchini raw or cook it in an oven, an air-fryer, a microwave, or on the stove or a grill. Here are five tips:

- Use an oven as an efficient way to cook a large quantity of zucchini at one time. First, cut the squash in half and then scoop out the seeds, creating a "zucchini boat." Drizzle the zucchini with olive oil and season to taste with salt and pepper. Roast cut side down at 400 degrees until a fork inserts easily, about 30 to 60 minutes. Remove from the oven and let cool.

- For a crunchy texture, consider using an air fryer. An air fryer commonly is used to create "zucchini chips." Start by thinly slicing the zucchini, then pat dry with a paper towel to get rid of excess moisture. Next, drizzle the zucchini with olive oil, salt and pepper. Place the slices of zucchini in the basket of the air fryer. Cook at 350 degrees for eight minutes. The cook time may vary, depending on the thickness of the zucchini slices. The zucchini chips will

appear slightly brown and have a crisp texture.

- Simply steam zucchini in the microwave. Cut the squash into bite-size pieces and place them into a microwave-safe bowl. Cover the bowl with a lid, but leave one corner of the lid slightly open. Cook the zucchini on high four to six minutes, until soft. If the zucchini is not yet tender, cook for another minute and repeat until you achieve the desired texture.

- Enhance the flavor of zucchini by sauteing on a stovetop. Slice the squash into circles or quarters to create bite-size pieces. Make zoodles, zucchini noodles, by slicing into thin strips with a knife or vegetable peeler. Next, mix the zucchini with 1 to 2 teaspoons of olive oil in a pan and cook over medium

heat. The zucchini should be tender and lightly brown. Season to taste with salt and pepper.

- To cook zucchini on the grill, slice the squash into 1/2-inch-thick pieces. Place in a bowl, then add a small amount of olive oil and sprinkle with seasoning. Place the zucchini on a grill pan or wrap in aluminum foil. If you want grill marks, slice the zucchini lengthwise and place over the grates. Grill zucchini over medium-low heat for three to four minutes per side.

Still have an abundant amount of zucchini? You can preserve the crop for year-round consumption. Freezing and drying are common preservation methods.

Freeze the zucchini by slicing or grating; blanch in boiling water for one minute if grated or three minutes if sliced. Allow to dry, then package in freezer containers. Label with contents and date.

To dry zucchini, start by cutting it into 1/4-inch pieces. Blanch the zucchini for one minute. Place in a dehydrator that is set at 155 degrees. Dry the summer squash for 10 to 15 hours, or until brittle.

Notice is hereby given to all landowners and renters in Sheridan County to do a 1st cut on all weeds and grasses along the shoulder right of way on township and County roads adjoining their land by **August 1, 2019** as provided for in section 63-05-01 and 02 of the North Dakota Century Code. If weeds and grasses are not cut by this time, the Sheridan County Commission will instruct the county road crew or organized township to cut weeds. The cost of cutting such weeds and grasses in each township will be charged \$125.00 per mile and such charges shall become part of the taxes to be levied against such land for 2019. Notice is also given to all landowners and renters that no electric fencing, encroaching (plowing up), and no sign removal is allowed along shoulder right of ways along township or County roads. 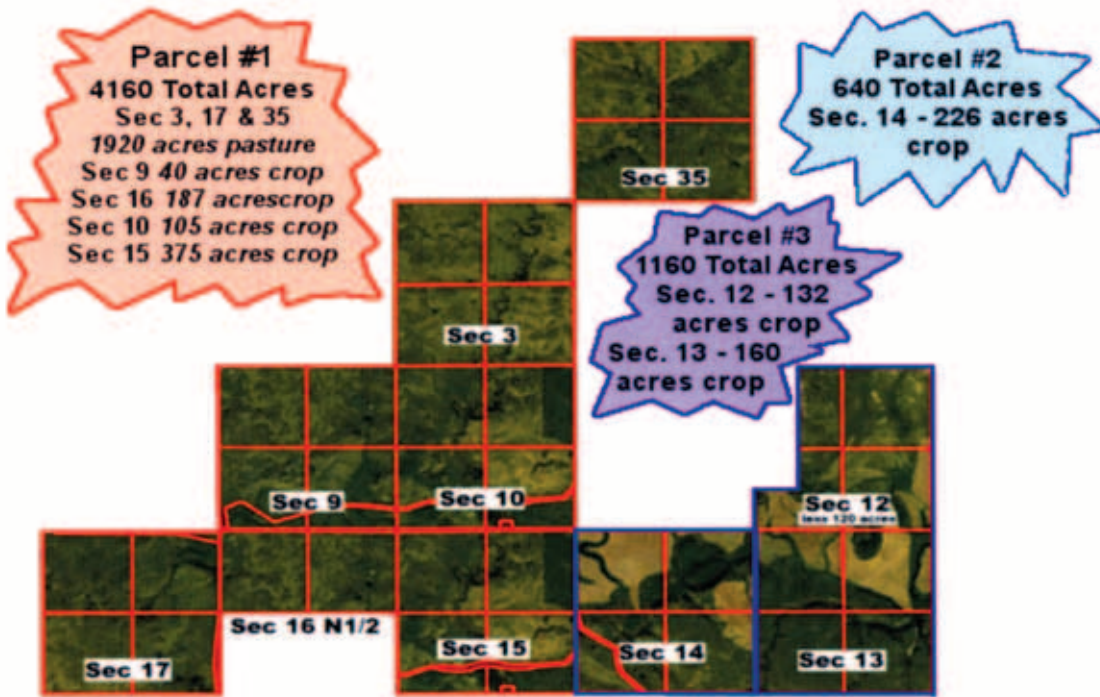
