The Gummer Affair DAKOTA DATEBOOK

December 28, 2020 — At during this time frame, and the that worked against him. On about 6:30 on the morning of June 7, 1921, William Gummer, a 22-year-old clerk at Fargo's Prescott

Hotel, told his boss, "Something's wrong in room 30." Marie Wick, a pretty 18-year-old brunette from northern MN was brutally

assaulted and killed in that room sometime during the night. Grev hairs were found clutched in her hand.

Fargo was an overnight stop for Marie as she traveled to see an aunt in Pettibone. During the train ride from Crookston, a middle-aged man

with a small mustache bought peanuts for her and another young woman, and the three spent the rest of the trip playing cards together.

Marie checked into the Prescott at 10 p.m., went out for ice cream with Arnold Rasmussen, a hometown friend, and returned an hour later.

She asked to be awakened at 6 a.m. and went to her room. When she didn't respond to repeated calls the next morning, William Gummer

went up and knocked on her door. When there was no response, he opened the door and found Marie's wrists lashed to the bed frame and

her head wrapped in pillowcases showing blood.

Authorities believed Marie was attacked while she slept and was choked into unconsciousness. She was gagged, tied up, and sexually

assaulted sometime between 12:30 and 2 a.m. Two women in the hotel heard noises – one other at about 4

a.m. Based on forensic evidence, it was speculated that the killer came back a second time, found Marie alive, retrieved the brass nozzle from a

fire hose down the hall and bludgeoned her with it. She died on the floor between the wall and her bed, having gotten one of her hands free.

The killer then laid her out on the bed, straightened her nightgown, neatly pulled up the covers and wrapped her head with the pillowcases.

He retied her loose hand, cleaned the hose nozzle and put it back where it belonged. Left behind were cigar ashes and a bloody towel.

The next morning, all the hotel guests were identified and fingerprinted except one, James Farrell, who was never found. Under pressure to

solve the case, a finger soon pointed at Gummer, the six-foot clerk from Mayville. Authorities claimed James Farrell was fictitious and that

Gummer or a friend forged the name into the registry to cover their tracks. Also, several women said Gummer made advances toward them

when they stayed at the Prescott, which he admitted.

The case was tried in Valley City, where the prosecution created a convincing case. The evidence was all circumstantial, and the defense put

on an equally compelling case. But Gummer had a personality flaw - often mentioned as "that smile" -

February 25, 1922, he was found guilty of 1st degree murder and sentenced to life in the Bismarck penitentiary.

Gummer steadfastly maintained his innocence. He repeatedly petitioned for a pardon but was continuously refused. Then, in 1934, three

people from Denver submitted affidavits stating one Arthur James told them that he and a man named Blackie Carter had killed Marie

Wick. But, an investigator rejected the theory, convinced that James wasn't in Fargo that night.

Ten years later, State's Attorney Ralph Croal found the mysterious Blackie Carter (alias Paul Welch) operating a filling station in St. Paul.


After interviewing Carter, Croal became convinced it was this man, not Gummer, who actually killed Marie Wick. Nearly 23 years after his

conviction, William Gummer finally won his pardon. On this date in 1944, he walked out of prison a free man. He was 44.

"Just 1 cup before bedtime," the text message said. "Take off your huge stomach."

I read it to my daughter.

"Your stomach isn't huge," she responded teasingly.

I'm not sure I liked her emphasis on "huge.'

At least she didn't restate the message to say "massive" or "colossal" or anything like that.

"Don't click on the message!" she added.

'I kind of figured that out," I said.

I thought I didn't click on it, anyway. I keep getting annoying messages from different numbers almostdaily.

One promised that you could "lose 43 pounds in two weeks." Another text promised that the recipientcould "drop from a size 3X to small in 7 weeks."

We have arrived at the time when weight loss ads will be flying at us in all directions. I was notexpecting them to arrive on my personal cellphone.

We don't promote miracles in the field of nutrition. We want people to follow nutrition and healthguidance based on best practices and research.

Seeking the easy path in nutrition or any part of our lives is tempting. The easy road is not always thebest path, however. Weight management or weight loss usually takes some effort on our part.

Being overweight based on our medical care provider's assessment does put us at risk for high bloodpressure, heart disease, cancer, diabetes and joint issues, among other conditions.

What can we learn from people who have successfully lost weight and maintained 25-year study that has tracked more than 10,000 people who lost weight and kept it off for along time. Their information is tracked on the National Weight Control Registry.

The participants had lost between 30 and 300 pounds and some had kept the weight off for one year to66 years. (Yes, you read that correctly.)

They didn't use any fancy potions or information from a text message. Almost all (98%) modified theirfood intake to lose weight and the vast majority (94%) increased their physical activity. Walking was themost popular activity.

They followed some basic "good habits" to cut calories and maintain their energy.

Most (90%) of the registry members exercised about an hour a day.

Most (78%) ate breakfast every day.

Most (75%) weighed themselves one or more times a week.

The majority (62%) of those successful at losing weight spent less than 10 hours watching TV perweek.

As we enter a time of sampling tasty goodies, keep in mind that small "tastes" can add up to lots ofcalories eaten. I adapted this scenario from University of Nebraska-Lincoln Extension. I think it showshow quickly you can consume extra calories.

Taste 1: You had a piece of peanut brittle that someone brought for treats at work. (80 calories)

Taste 2: Someone else brought chocolate-covered cherries to work, so you had a couple (because they are fruit, right?) (60 calories)

Taste 3: You baked cookies and one broke. You ate a piece. (30 calories)

Taste 4: You were thirsty and had a half-cup of oldit? I looked at theresults of a fashioned eggnog before your guests arrived fordinner. (200 calories)

Taste 5: Only a couple of tablespoons of candied sweet potatoes were left in the bowl, so youdecided to eat them. (60 calories)

That adds up to 430 calories of "tiny tastes." Just 100 extra calories per day can lead to a 10-poundweight gain in one year.

Enjoy the flavors of the holiday season. Slow down and focus on the goodies you are consuming. Enjoythe aroma, texture and flavor.

Instead of a recipe, this week I invite you to use your creativity to create flavored water that isrefreshing but has few calories.

Flavor-infused Water

Start with clean hands, containers, cutting boards and knives. Rinse fruit and herbs thoroughly.

Try one of these flavor addins:

Option 1. Citrus water: 1/2 cup sliced oranges, lemons or grapefruit plus 2 quarts water

Option 2. Strawberry kiwi water: Three sliced strawberries plus one peeled, sliced kiwi plus 2 quartswater

Option 3. Watermelon rosemary water: 2 cups seedless watermelon (cut in chunks or balls) plus onesprig of rosemary plus 2 quarts water

Option 4. Raspberry lime water: 20 crushed raspberries plus two sliced limes (without rind) plus 2quarts water

Refrigerate overnight.

Don't mix batches. Use up the batch, clean the container and make a new batch.

Ice fishing offers up some incredible opportunities at dawn and dusk, and even late into the night for crappies, walleyes and other fish that forage in low light or even in times of complete darkness when a hot bite can materialize out of the depths.

As a result, having the right lighting system both for the

post-dusk darkness, it's likely an experienced outdoorsman has a stash of headlamps at hand.

With their relatively low price tag, it never hurts to have a few extras laying around, and perhaps an upgrade is in order as brighter new technologies take hold in the industry. A headlamp is a vital tool that helps illuminate a path to a hardwater fishing spot and allows anglers to see the condition of ice ahead of them and where their holes are, making things a bit safer with a simple beam of light for winter fishing.

Like all gear for hardwater angling, make sure the model can take a beating and can handle the colder temperatures. They make great stocking stuffers, and at worst end up being great safety beacons for these dark winter mornings and evenings when walking the dog.

are going to be mounted on the poles and posts of a portable ice shack.

For customizable strips of light, inspect those LED ropes to make sure that they are waterproof and have either a sealed power source or are run off a standard 12-volt battery like the one used in most on-ice sonar units.

For a more permanent positioning, utilize zip ties to secure the light ropes to the bars of an ice shack. For easy adjustment and a more temporary set-up, use Velcro strips that can be quickly removed at the end of a fishing outing. Those with more mechanical skills than I are able to put together some impressive illumination with all sorts of attachment hacks to light up their shacks just the



individual and for a shack will help make things easier to see during set-up and takedown, travel around a set of hot holes, and in those moments where lure changes need to occur quickly.

Lighting can be as inexpensive as a simple light bar or headlamp or today's modern portables can be tricked out with ropes of LED bulbs which give off ground effects as cool as a car out of a scene from Tokyo Drift.

Personal Illumination

A headlamp is an essential tool from season to season in the outdoors and is always a welcome gift in someone's stocking this time of year. Whether used to work the late night hours during summer fishing outings, or to help with the hump into or out of a deer hunting spot deep in the woods in the pre-dawn and

Shine for Shacks

As the ice fishing shelter market has exploded over the past two decades, so too have the illumination options. From light bars to sealed ropes of LED bulbs which can be strung and mounted along poles, sled bases or around holes to help see the action, on-ice illumination has advanced to match the times and the way anglers fish on hardwater.

Banks of bulbs in heavyduty plastic casings absorb the blow of shacks that are quickly opened and closed in those instances where a tip-up pops and provide convenient light options that last season after season. Check to make sure that the cases are waterproof and sturdy for any options that


