# UND vs NDAC

## DAKOTA DATEBOOK

Dakota Datebook written by Merry Helm

November 3, 2021 — The first football game between the University of North Dakota and the North Dakota Agricultural College (now NDSU) took place on this date in 1894. UND players called themselves the Flickertails, and NDAC players were called the Farmers.

UND had no coach and, until the NDAC match up, it

had only been playing towns close enough to Grand Forks for easy travel. The Bison won that first game by either 16 or 14 points – depending who you ask – but Grand Forks claimed the Ag School cheated, because they had a professor on the team. Thus began a legendary rivalry in which the schools played against each other more than any other two teams in Division II football history.

# All Hallows' Eve

On Oct. 31, 1804, the men of the Corps of Discovery were searching for a location to build their winter quarters, the structure that would be known as Fort Mandan. While they did not find a suitable site that day, the enlisted men spent the evening dancing for Mandan chief Sheheke-Shote.

While it may seem that they were celebrating the now ubiquitous holiday we know as Halloween, William Clark made it clear that evening dancing was a common occurrence among the men.

There is no record of the men of the Lewis and

Clark Expedition observing Halloween, or All Hallows' Eve, during their 28-month journey. However, the holiday had been around and evolving for centuries up to that point.

Halloween developed from ancient Celtic traditions. Oct. 31 marked the end of summer, and the Celts would celebrate with Samhain, a festival acknowledging the changing season from summer to winter. Traditionally during this festival, a bonfire would be lit, food was prepared, and costumes worn to ward off evil spirits who may be entering during the dark season.

After the Roman Empire conquered Celtic territory, early Christian officials attempted to dissuade people from celebrating Samhain and other secular festivals. Pope Gregory III deemed Nov. 1 All Saints' Day, a day to honor Christian martyrs and saints. All Saints' Day was also known as All Hallows' Day.

The combination of Christian and secular traditions lay the foundation of the Halloween that is

celebrated today. While All Hallows' Eve was not widely celebrated in colonial New England for religious reasons, it was more popular in Maryland and in the southern colonies, where traditions included telling ghost stories and making mischief. These are the celebrations that would have occurred during Lewis and Clark's time.

By the late 19th century, costumes made a comeback and the Halloween we celebrate today came into form. Communities hosted parties with games and food where members dressed up for one night. By the mid-20th century, going door to door became more widespread as mass-produced candy became widely available.

We do not know if any of the expedition members observed Halloween or its predecessors. However, they did spend the night dancing and enjoying each other's company, which is not unlike the Halloween celebrations of today.

### SPOOKY HALLOWEEN M&M COOKIES

- 2 1/2 cup All Purpose Flour
- 1 cup Hershey's Dark Cocoa Powder
- 1 teaspoon Baking Powder

- 1 cup Brown Sugar
- 1 cup Melted Butter

Preheat the oven to 350F or 180C.

In a mixing bowl, combine AP Flour with Baking Powder and Dark Cocoa Powder. Mix the Melted Butter with Vanilla Extract and Brown Sugar. Mix the flour mix with the wet ingredients. Fold everything using a rubber or silicone spatula. Add some milk along with a drop of Black Gel Food Color, and make a thick cookie dough.

If your cookie dough is too thin and runny, add some more flour and mix with all the other ingredients. Learn from the video for better reference of the consistency of the cookie dough.

Cover and freeze the cookie dough for 3 minutes. After 3 minutes, use a cookie scooper to scoop out cookie dough balls. Flatten it out, with the back of a spoon or spatula. Stuff the cookies with a few M&Ms on top. Bake these cookies for 11 minutes. Once baked add more M&M Candies on top. Serve warm with a glass of milk.

Remove from heat and serve immediately, topped with whipped cream and sprinkle the green sprinkles and add 2 eyes.

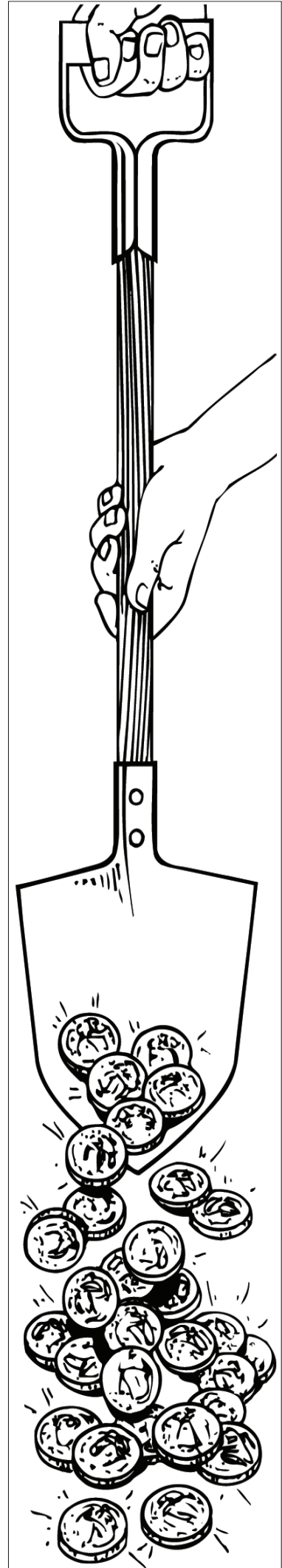
