"U. of Wyoming Transgender Lawsuit: Who is a Woman?"

tected by the Constitution—

A federal lawsuit reflective of the nationwide culture wars is challenging the right of a University of Wyoming sorority to induct a transgendered woman, raising questions of central importance to the First Amendment Right of Freedom of Association and Title VII of the 1964 Civil Rights Act. The issues in the suit are likely to be replicated across the nation as the judicial system wrestles with legislative efforts to regulate, distinguish and deny opportunities and rights of the LG-BTQ community.

Seven past and present members have filed suit in federal court in Wyoming, asserting that the University of Wyoming chapter of Kappa Kappa Gamma and the national office violated the sorority's mission, purpose and bylaws when it inducted Artemis Langford, who identifies as a woman.

Resolution of the lawsuit should hinge on the question of who, precisely, has the authority to determine whether a transgendered woman has satisfied the criteria for membership in Kappa Kappa Gamma. The local chapter, backed by the parent organization, has concluded that Langford meets the criteria for membership, a decision grounded in its First Amendment right of Freedom of Association.

Freedom of Association is not enumerated in the Constitution, but it was initially recognized by the Supreme Court in 1876, in United States v. Cruikshank as an implied right, derived from the First Amendment's guarantee of the "right of the people peaceably to assemble." The existence of the right of freedom of association is non-controversial, though its scope and contours have inspired debate over the years. In a raft of decisions, the Court has also grounded it in the right to petition government, the right of free speech and privileges and immunities of citizenship. Like all other rights pro-

Iture enumerated and implied right alike—freedom of association ming is not absolute but is subject to reasonable limitations requesquited by substantial public interests.

Right In a case that lies at the

heart of the pervasive cultural wars afflicting our nation, the Supreme Court, in Boy Scouts of America v. Dale (2000), invoked freedom of association to uphold the right of the Boy Scouts to revoke the membership of an assistant scoutmaster after he publicly announced his sexual orientation by leading a gay group at Rutgers University. The Court, in a 5-4 opinion written by Chief Justice William Rehnquist, held that freedom of association gave the Boy Scouts the right to bar "homosexuals" from serving as troop leaders. The Court left to the Boy Scouts the right to determine the criteria that should govern its member-

The Supreme Court's ruling in Boy Scouts of America should guide the federal court's decision in the Wyoming case involving the right of Kappa Kappa Gamma to determine its membership. Judicial deference to the conclusion of both the local chapter and the parent organization, grounded on the rational basis test, that Langford meets the criteria for induction in the sorority, avoids the need for the court to determine whether Langford qualifies as a transgendered woman and whether her admission perverts the organizational mission of Kappa Kappa Gamma.

In Boy Scouts of America, the four dissenters failed in their effort to persuade the majority to engage in a searching analysis of whether the membership of a gay scoutmaster truly compromised the mission, spirit and principles of organization. Chief Justice Rehnquist's opinion for the Court deferred to the Boy Scouts' own deter-

mination of that question. Otherwise, Rehnquist wrote, the presence of a "homosexual" scoutmaster "would, at the very least, force the organization to send a message, both to the young members and the world, that the Boy Scouts accepts homosexual conduct as a legitimate form of behavior."

By parity of reasoning, the institution of Kappa Kappa Gamma, rather than disappointed individual members, should be able to determine, on principles of freedom of association, whether induction of a transgendered woman is consistent with its organizational principles and message.

Another Supreme Court precedent has a bearing on the sorority case. In Bostock v. Clayton County, in 2022, Justice Neil Gorsuch held for a 6-3 majority that the Title VII of the 1964 Civil Rights Act prohibits employers from discriminating against any person because of that person's "race, color, religion, sex, or national origin." He wrote: "Discrimination on the basis of homosexuality or transgender status" violates the landmark statute.

The Court's ruling in Bostock repudiates the plaintiff's argument in the Wyoming case. While sororities and fraternities retain on freedom of association grounds the right to remain single-sex organizations, they may not, under the reasoning of Bostock, deny admission to a student for reasons of identity. To do that, as Justice Gorsuch held, would violate Title VII's prohibition against sex discrimination.

The Wyoming sorority case embodies issues that will be raised in lawsuits throughout the nation. The immediate issue before the federal court, the one inflaming the culture wars and one certain to generate controversy grounded in emotions and politics, is clear: Who decides if a transgendered inductee qualifies as a woman?

DAKOTA DATEBOOK

Titanic Impact

April 13, 2023 — In 1912, on this date, passengers aboard the doomed ship Titanic were unaware of what fate waited for them. One day more, and the ship would sink, taking with it approximately 1,500 lives.

The disaster impacted people the world over. Even North Dakota, far removed from the perils of the ocean, was deeply affected. E.W. Chaffee, a businessman and farmer of Aneta, was returning from a European vacation with his wife, Carrie, onboard the Titanic. Although his wife survived, he did not, and his body was never found or identified. Oskar Hedman, from Beach, had third-class passage aboard the ship, and managed to survive.

There were other stories, though-such as the near miss case of Dr. and Mrs. McCannel from Minot. They had been away from home for a long time, visiting Vienna and other parts of Europe in 1911 and 1912, so when it was finally time to depart, they made arrangements to hurry their voyage home. They planned to travel on the Titanic, but the ship's schedule changed, and they were forced to book passage on the Carmenia, instead. They were disappointed to miss travelling aboard the ship they had heard so much about, but they were anxious to get home.

Onboard their ship, the

McCannels ran into the field of icebergs that would later sink the Titanic. Dr. McCannel took a photo of one of the larger ones—it was tall, with a point rising some 200 feet above the surface of the water. The ship cut its engines until they drifted clear of the hazard. They heard no more about the icebergs or the famous ship until April 15, when they read about the tragedy in the newspapers.

For years afterward, Dr. Mc-Cannel wondered if the fatal iceberg that sank the Titanic, described as having a "spire like a cathedral," was the same one he had taken a picture of, which hung thereafter on his office wall.

The stories and the feelings survive, evident in the scholarship, the history and the memories. Even today, we can understand the relief the McCannels must have felt when, after they arrived at home, a Scottish friend said to them, "Your time had na come."



Outdoor Notes:

*New fishing licenses are now required.

*Permanent ice houses can still be used but can't be left unattended on lakes.

*Be mindful of parking when accessing area lakes; not blocking roadways or snow removal operations.

*Reminder that it's illegal to chase, harass, or pursue any wildlife species with motorized vehicle.

*Ice is never completely safe. Avoid areas with vegetation, moving water, pressure ridges, and springs. Check conditions as you go along on the ice and don't move around at night.

*April 8: Maple Sugaring Day, Fort Stevenson State Park, Garrison, 10 a.m.

*April 8: Spring turkey season opens.

Fishing:

Lake Sakakawea elevation, April 3: 1,824.74 feet above mean sea level; 15,900 cubic feet per second (CFS) Garrison Dam average daily releases.

Missouri River gauge height, Stanton: River stage, 7.69 feet.

Missouri River gauge Washburn: River height, stage, 8.56 feet.

*N.D. Game & Fish Dept. game wardens: Little activity on the east end of Lake Sakakawea. No reports from area lakes.

*Lakes Audubon Sakakawea, Cenex Bait & Tackle, Garrison: Somewhat improving walleye activity around Steinke Bay on the east end of Lake Sakakawea. Lake Audubon remains slow.

Audubon Sakakawea, Hwy. 83 Lawn & Leisure, Garrison: Look for pike activity around back bays on the east end of Lake Sakakawea. Try 6 to 12 feet around Steinke, Centennial, Garrison, Douglas bays. No walleye reports.

*Lake Sakakawea, New Town: Van Hook Arm and riv-

er portion of Lake Sakakawea around New Town remain quiet. Look for pike activity to start once the creeks start running into the back bays.

*Missouri River, Enerbase of Washburn: Some activity on Nelson Lake and Lake Sakakawea.

*Missouri River System, Scott's Bait & Tackle, Pick City: Missouri River and Lake Sakakawea remain quiet with little activity.

*McLean Co. area lakes, Cenex of Wilton: Some activity on Hofer Lake and Lake Sakakawea as well as the open water of Nelson Lake using minnows.

DAKOTA GARDENER

Between the pages

I didn't make any New Year's resolutions this year. So, I haven't broken any resolutions this year!

We are three months into 2023, and I'm bringing up resolutions. Why?

In January, a lot of my friends on Facebook were posting about the books they had read in the previous year. The lists were quite impressive. People were reading about leadership, self-improvement and philosophy. And they read quite a few books.

I didn't want to share my list of adventure stories and shoot-'em-up books. I felt rather shallow and embarrassed.

With some reflection, I realized that I actually have read a number of books in recent years that go beyond the fiction that I sometimes lose myself in. Here are five tree-related books I've read that you might find interesting.

Free" by Suzanne Simard. Professor Simard reflects about her life, both within her family and professionally as a forest scientist. It's a fascinating journey, linking science and her experiences as a woman in a highly male-dominated profession. Her groundbreaking research over the past 30

years has changed our view of forest ecology and the relationships between individual trees through the underground fungal network of mycorrhizae.

"10,000 Days in the Woods" by Russ Danielson. If you do the math, 10,000 days equates to more than 27 years. Danielson's story is that of a field forester, beginning as a teenager and working throughout the northern United States. It includes a two-year stopover in Bottineau, North Dakota, as he earned his associate degree in forestry. This book is a collection of short essays – two to five pages each – and is much less technical than Professor Simard's book.

"The Wild Trees: A Story of Passion and Daring" by Richard Preston. This is the tale of the search for the world's tallest tree. Northern California's coastal redwoods serve as the backdrop for a storyline that "The Search for the Mother reads like a novel. The journey recounted by Preston mixes the personal history of the scientists and the fascinating ecosystem they find in the forest canopy, well over 300 feet above the forest floor.

"Tree Story: The History of the World Written in Rings" by Valerie Trouet. This is an amazing book. Professor

Trouet describes the science of tree rings, dendrochronology, through stories of the history and ecology that have been uncovered over the years. The book includes a glossary of technical terms and a citations list for those wanting to learn more about this fantastic science. It also includes a "playlist" with songs by Toto, Neil Young and REM, among others. How cool is that!

"The Tree Farm" by Robert Treuer. This is the book that made me become a forester. I re-read it recently and I find it as inspiring today as I did in the mid-1980s. The story follows Treuer's experiences following World War II that led him to a northern Minnesota tree farm in the 1960s. There are challenges to life in the north woods, both personally and ecologically. Nevertheless, life continues and good can come from persisting through hard times.

In addition to these treerelated books, I also read two textbooks about the ecology of rivers and streams, plus one about brain function in bees. Maybe I'm not as shallow as I thought.

PRAIRIE DOC PERSPECTIVES

By Andrew Ellsworth, MD Hindered by pain in your heel?

If you have pain on the bottom of your foot at the heel, especially when you take your first steps of the day, you likely have plantar fasciitis. One of the most common causes of foot pain, plantar fasciitis pain can subside with time, but sometimes the pain keeps people from doing what they love, whether that be running, walking, or other pleasures of life. I once saw a young woman suffering from plantar fasciitis who got some relief from an injection. A few years later she returned wanting another injection so she could dance pain-free at her own wedding.

The bottom of the foot has thick, white fibers called the plantar fascia. On one end it connects to the heel bone, and on the other the fibers connect to each of the toes. This helps support the foot, tightening as we walk and keeping the arch of the foot elevated like the bowstring maintaining the curve of the bow.

Pain can arise from stress on the plantar fascia where it connects to the heel bone, the tuberosity of the calcaneus. This spot, right by the heel on the underside of the foot, can be quite tender to touch when plantar fasciitis is active. It often is most painful when first walking in the morning or after periods of rest. The pain can linger for months or

Sometimes referred to as heel spurs, on x-ray this spot may show calcifications in the fascia that have formed from years of stress or inflammation. The presence of these heel spurs does not necessarily mean someone will have pain. Some have pain from plantar fasciitis without heel spurs, and some with heel spurs do not have pain.

Causes of plantar fasciitis include poor fitting shoes, starting a new exercise routine such as running, obesity, prolonged running or standing, flat feet, and more. The exact cause remains unclear.

Initial treatments include avoiding activities that make it worse, stretching exercises that may include pointing the toes upward and stretching the calf muscles, avoiding the use of flat shoes, avoiding walking barefoot, heel shoe inserts, a short term trial of NSAIDs like ibuprofen, or possibly a steroid injection. Later, if needed, molded inserts, night splints, immobilization in a boot or cast, or even surgery may be considered. Thankfully, even without treatment, plantar fasciitis may often go away on its own within a year.

Plantar fasciitis may only be a spot on the bottom of the foot, but I do not envy those who are reminded of it with every step.



I grew up eating "Tator Tot Hotdish" in Minnesota, and my kids still enjoy this comfort food. My colleagues modified a recipe to be healthier and also slow-cooker friendly.

Healthier Slow-cooker Tator Tot Hotdish

- 1 pound ground turkey or extra-lean beef, cooked
 - 1 small onion, diced
 - 1 16-ounce bag frozen mixed vegetables
- 1 (14.5-ounce) can cream of mushroom soup, reduced sodium
- 1 (5.3-ounce) container plain Greek yogurt
- 1 tablespoon garlic powder
- 8 ounces tater tots
- 3 tablespoons colby jack cheese, shredded

Brown ground turkey or beef in a skillet. Add onion and cook until translucent. Add ground turkey and onion mixture, vegetables, soup, yogurt and garlic powder to slow cooker. Stir to combine. Top with tater tots and sprinkle with shredded cheese. Cook on low for 6 hours or on high for two to three hours.

Makes six servings. Each serving has 230 calories, 7 grams (g) fat, 23 g protein, 18 g carbohydrate, 1 g fiber and 290 milligrams sodium.

Child Abuse Prevention Month this April to highlight the importance of "Prevention in Partnership

BISMARCK, N.D. - In recognition of national Child Abuse Prevention (CAP) Month in April, Prevent Child Abuse North Dakota (PCAND) and North Dakota Health and Human Services (HHS) are ioining parent and family resource centers, local child welfare service providers and other partner agencies in highlighting the importance of working together in communities to serve and support children and families so that child abuse and neglect can be prevented.

PCAND Executive Director Christy Dodd said, "With our national organization Prevent Child Abuse America, we are pleased to lead this year's awareness and impact campaign, 'Building Together: Prevention in Partnership.' Our team is dedicated to bringing new and existing partners together to support North Dakota children and families."

Annually, there are between 1,000-1,200 confirmed cases of child abuse or neglect in North Dakota. Extreme stress, unmet needs and uncertainty for families may increase the risk of child abuse and neglect.

HHS Children and Family Services Section Director Cory Pedersen agreed collaboration and local community engagement and support are effective strategies to reduce child abuse and neglect.

"One of our key priorities

is strong, stable families," he said. "Communities have a vital role ensuring children have positive experiences and families have the resources and support they need at the right time before they are in crisis."

Throughout April, PCAND, HHS and local partners are using the metaphor of building blocks and construction as they promote local CAP month activities and events and reinforce the message that prevention cannot happen alone.

They encourage North Dakotans to help raise awareness and impact this April in the following ways:

- Wear blue on March 31, Wear Blue Day, to show support for children and families and help build momentum leading into Child Abuse Prevention Month. Post a photo or video on social media and include #WearBlueDay2023.
- Participate in local 2023 Child Abuse Prevention Month activities and events. Hosted by partner agencies across North Dakota, local activities include family day make and take events, book studies, educational presentations for families on stress and resilience, newborn care, safe sleep and more; family fun nights; cooking with kids class; community 3K/5K/ walks and runs and more. - Participate in Prevent Child Abuse America's nationwide Digital Advocacy Day on April 19 to advocate for increased investments for Title II, Community-Based Child Abuse Prevention grants of the Child Abuse Prevention and Treatment Act to provide states and communities the resources to implement community-based solutions to prevent child abuse and neglect.

Burgum signs bill granting emergency aid to help cover extraordinary snow removal costs

BISMARCK — Governor-Doug Burgum signed legislation Tuesday that provides emergency grants to help cover extraordinary snow removalcosts for local governments. The governor and other state leaders also highlighted how state agencies are collaborating with local entities and each other to prepare for and respond to this week's major snowstorm and the high likelihood of spring flooding.

Senate Bill 2183 appropriates \$20 million for emergency snow removal grants to eligible tribal governments, counties, cities and townships. Joining Burgum for a bill signing ceremony at the Bismarck District Office of the North Dakota Department of Transportation (NDDOT) was the bill's prime sponsor, Sen. Terry Wanzek of Jamestown, and co-sponsors Rep. Mike Brandenburg of Edgeley, Sen. Jerry Klein of Fessenden, Sen. Mark Weber of Casselton. Rep. Keith Kempenich of Bowman and Rep. Alisa Mitskog of Wahpeton.

"This record-setting winter has strained resources at everylevel of government," said Burgum who urged support for the aid in his Jan. 3 State of the State address. "By expediting \$20 million in emergency snow removal grants to qualifying city, county, township and tribal governments, we can relieve some of the burden on costs from Oct. 1, 2022, through Dec. 31, 2022, and an additional \$5 million for reimbursement for the period of Oct. 1, 2022, through April 30, 2023. Any unallocated funds from the first period can be made available as part of the second period. The bill will reimburse up to 60% of costs exceeding 150% of the average of four of the last five years' snow removal costs. Nearly all of North Dakota except for the northwest corner was under a blizzard warning from this morning through Wednesday night, with total snow accumulations of 8 to 17 inches and wind gusts of up to 55 mph forecast for the Bismarck area, with higher snow totals to the east. Heading into this week, Bismarck was only 6.3 inches short of its record seasonal snowfall total of 101.3 inches set in the winter of 1996-97. "This has been trying on our communities and local taxpayers and help was one for the record books, it doesn't have to haunt their

financial books.' Senate Bill 2183 passed the Senate 46-0 and the House 91-1. The bill provides \$15 million in funding for reimbursement grants to tribes, counties, cities and townships for snow removal costs from Oct. 1, 2022, through Dec. 31, 2022, and an additional \$5 million for reimbursement for the period of Oct. 1, 2022, through April 30, 2023. Any unallocated funds from the first period can be made available as part of the second period. The bill will reimburse up to 60% of costs exceeding 150% of the average of four of the last five years' snow removal costs.

Nearly all of North Dakota except for the northwest

corner was under a blizzard warning from this morning through Wednesday night, with total snow accumulations of 8 to 17 inches and wind gusts of up to 55 mph forecast for the Bismarck area, with higher snow totals to the east. "This has been trying on our patience, our resiliency, our fortitude and our budgets," Wanzek said. "I have 100% faithin the spirit of North Dakota citizens to be able to pull through this tough winter. And while we as leaders have little influence over controlling Mother Nature, we do have some ability to provide financial relief for their burgeoning budgets."

"As we came into Bismarck back in November, we knew we had problems. We knew that the snow levels were significant and we were going to have what looked like a tough winter – and we did, and we have, and it isn't over yet," Brandenburg said. "And as chairman of Nora Township, I really want to tell you that the people out there in the townships and the cities and counties, they need this. They really need his help."


The Department of Emergency Services will be sending out application forms through the North Dakota League of Cities, North Dakota Association of Counties and each county's Emergency Manager by the end of the week. All funds will be disbursed by June 30, state Homeland Security Division Director Darin Hanson said.

State leaders including Maj. Gen. Al Dohrmann, director of the North Dakota Department of Emergency Services; North Dakota Department of Transportation (NDDOT) Director Ron Henke; Col. Brandon Solberg, superintendent of the North Dakota Highway Patrol; and North Dakota Department of Water Resources Director Andrea Travnicek, described how state agencies have collaborated with local officials and each other to prepare for this week's storm and subsequent flooding, including pre-positioning personnel and equipment in the hardest hit areas.

"We are synched, we're coordinated and we'll be ready to go," Dohrmann said.

Officials urged motorists to be patient, check the ND Roads app for road conditions, heed no travel advisories and give snow plows room to operate. Residents were reminded to have their homes stocked with food, water and medicine; monitor local weather and news and have a batterypowered radio in case of power outages; check gas meters and furnace vents to make sure they're clear of snow; and take the time to check on their neighbors. Burgum and others also expressed gratitude for the tireless work of snowplow crews, law enforcement, first responders, radio dispatchers, emergency management personnel and others.


